SUBJECT: Notice of proposed rule review for 31 TAC Chapter 355

ACTION REQUESTED

Consider authorizing the publication of a notice of intent to review rules in 31 Texas Administrative Code (TAC) Chapter 355.

BACKGROUND

This action proposes to publish notice of the TWDB's review of rules in Chapter 355 pursuant to the TWDB's rule review schedule. Chapter 355 covers the Research and Planning Fund, which may fund research contracts, flood protection planning contracts, economically distressed areas facility engineering, regional facility planning, regional water planning grants, and environmental flows grants. The flood protection planning contracts may include funds transferred from the Flood Infrastructure Fund.

KEY ISSUES

The TWDB is required, pursuant to Texas Government Code § 2001.039, to review existing rules every four years. As part of its review, the TWDB must determine whether the factual, legal, and policy reasons for adopting the rules continue to exist and whether the rules should be repealed, readopted, or readopted with amendments. Any suggested rule changes identified pursuant to this review will be brought to the Board in a separate Board Item for a formal rulemaking process.

The notice of intent to review rules will be published in the *Texas Register* and open for a 30-day public comment period.
