- SUBJECT: Notice of adoption of rule review for 31 TAC Chapters 371 and 375

ACTION REQUESTED

Consider authorizing the publication of an adoption of a review of rules in 31 Texas Administrative Code (TAC) Chapters 371 and 375.

BACKGROUND

On October 5, 2023, the Texas Water Development Board (TWDB) authorized the publication of several notices of intent to review TWDB rules throughout Title 31, Part 10 of the TAC. This item proposes to publish notice of adoption of TWDB's review of the rules in Chapters 371 and 375.

KEY ISSUES

The TWDB is required pursuant to Texas Government Code (Tex. Gov't Code) § 2001.039 to review all existing rules every four years. Pursuant to that review, it must either re-adopt, re-adopt with amendments, or repeal existing rules. The TWDB has completed its review of the rules in Chapters 371 and 375 and recommends that the rules be re-adopted, as the legal reasons for the rules continue to exist. Amendments may be published in the future.

RECOMMENDATION

The Executive Administrator recommends the publication of an adoption of rule review for 31 TAC Chapters 371 and 375 to comply with Tex. Gov't Code § 2001.039.
