SUBJECT: Notice of proposed rule review for 31 TAC Chapter 362

ACTION REQUESTED

Consider authorizing the publication of a notice of intent to review rules in 31 Texas Administrative Code (TAC) Chapter 362.

BACKGROUND

This action proposes to publish notice of a review of the TWDB's rules in Chapter 362, pursuant to the rule review schedule.

Chapter 362 contains the TWDB's rules that govern the state flood plan, which includes definitions, guidance principles for the state and regional flood planning, and requirements related to the contents and adoption of a state flood plan. The vast majority of this chapter was recently adopted to be effective October 2023.

KEY ISSUES

The TWDB is required, pursuant to Texas Government Code § 2001.039, to review existing rules every four years. As part of its review, the TWDB must determine whether the factual, legal, and policy reasons for adopting the rules continue to exist, and whether the rules should be repealed, readopted, or readopted with amendments.

Any suggested rule changes identified as part of the review will be brought to the Board in a separate Board Item for formal rulemaking process. The notice of intent will be published in the *Texas Register* and will be open for a 30-day comment period.

RECOMMENDATION

The Executive Administrator recommends the publication of notice to review rules in Chapter 362 to comply with Texas Government Code § 2001.039 and the TWDB's rule review schedule.

Changes to the rules identified as part of this review process may be addressed in a separate rulemaking.
