

## **Continued Project Solicitation for SFY 2016 Clean Water and Drinking Water State Revolving Funds**

The Texas Water Development Board (TWDB) is soliciting projects for the Clean Water and Drinking Water State Revolving Fund programs. In order to assist with your scheduling needs, project Information Forms will now be accepted year-round. All eligible projects submitted will be processed and added to the Project Priority Lists for funding consideration.

Listed below are brief descriptions of the programs, with links:

- Clean Water State Revolving Fund (CWSRF) funding for wastewater collection and treatment, wastewater recycling and reuse facilities, storm water pollution control, nonpoint source pollution control, and estuary management projects. - **Drinking Water State Revolving Fund** (DWSRF) funding for projects that will bring existing public water systems into compliance with drinking water regulations, upgrade or replace water supply infrastructure, consolidate water systems, purchase capacity in water systems, and provide source water protection. These programs provide below-market interest rate financing, including special subsidies for entities that qualify as disadvantaged, projects that contain green components, and in the DWSRF program, subsidies for very small systems and projects meeting urgent need criteria.
