Good afternoon,

Attached for reference during your plan development is a list of entities that are required to submit drought contingency plans to the TCEQ (due to TCEQ May 1<sup>st</sup>).

This list is being provided as a resource to assist planning groups in meeting the regional water planning rule [31 TAC 357.34 \(j\)\(1\)](#)\* and requirements in regional water planning contract [Exhibit C, Section 2.5.2.6](#) (page 57).

To meet these requirements, planning groups will need to describe drought management *measures* for all water user groups included in the attached list, within the planning region. Drought management measures are defined in [31 TAC §357.10\(9\)](#) as demand management activities to be implemented during drought that may be evaluated and included as water management strategies. This may include summarizing existing information from the drought contingency plans. This does *not* require that drought management strategies be evaluated and recommended.

More information may be found in Exhibit C. If the planning group includes the drought management measure information as part of the drought contingency plan summary information presented in Chapter 7, please also include a reference to that material within Chapter 5 of the regional water plan.

*\*note this rule item may be renumbered following regional water planning rule revisions this spring.*
