David Nabors made a motion to approve the minutes from the April 15, 2015 meeting. Darwin Douthit seconded the motion. Motion carried, all voting aye.

David Nabors made a motion to approve the Public Notice of expiring terms for NETRWPG voting members and for the vacancy due to the resignation with no changes contained in one notice. Robert Holt seconded the motion. Motion carried, all voting aye.

David Nabors made a motion to set Public Hearing for the Initially Prepared Plan of Region D on Tuesday, July 14, 2015 at 10 a.m. with the regular meeting to begin at 1 p.m. after the Public Hearing. Danny Evans seconded the motion. Motion carried, all voting aye.

Richard LeTourneau made a motion to authorize Northeast Texas Municipal Water District to be NETRWPG's designated political subdivision for the 5<sup>th</sup> cycle of planning. David Nabors seconded the motion. Motion carried, all voting aye.

Bill Kirby made a motion to authorize the Northeast Texas Municipal Water District to execute the 5<sup>th</sup> cycle of planning prior to August 31, 2015. Richard LeTourneau seconded the motion. Motion carried, all voting aye.

David Nabors made a motion to authorize the submittal Request for Proposal for engineering and related activities for the next round of planning. Danny Evans seconded the motion. Motion carried, all voting aye. NETMWD will send out the request and complete the screening process. It is anticipated that NETRWPG will vote in September or subsequent meeting on the selection of consultants for the fifth cycle of planning.

Tony Smith with RPS/Espey reported that the Initially Prepared Plan had been successfully turned in to the TWDB. Mr. Smith informed that everything is on schedule, within budget, and 66% complete. Mr. Smith stated that the IPP Hearing is officially scheduled in July, presented an IPP Process Schematic (TWDB), and informed that some comments had been received from the City of Redwater and the City of Canton. Temple McKinnon reported that the TWDB was reviewing the IPP. David Nabors informed that the GMA #8 was meeting today and Region C meeting is scheduled for June 24, 2015.

David Nabors made a motion to approve the Financial Report by the Administrator, including approval for payment of the RPS/Espey Consultant invoices. Robert Holt seconded the motion. Motion carried, all voting aye.

The next meeting of the regional water planning group was set for July 14, 2015.


