Larry Calvin seconded the motion. Motion carried, all voting aye.

Tony Smith with RPS/Espey reported that everything was moving along schedule. Mr. Smith also mentioned that all public comments on the Initially Prepared Plan were due on September 14<sup>th</sup> and that the final plan would be reviewed and approved at a later date in November. He also mentioned that 18 comments had been received and that a Final Plan was to be adopted by December 1<sup>st</sup>.

Shirley Shumake made a motion to approve the Financial Report by the Administrator, including approval for payment of the RPS/Espey Consultant invoices. Darwin Douthit seconded the motion. Motion carried, all voting aye.

By consensus, the next meeting of the regional water planning group was set for September 23, 2015.
