Consider authorizing the Executive Administrator to (a) negotiate and execute contracts for the 2026 regional water plans in an amount not to exceed \$2,844,856 including permission to allow the TWDB to reimburse planning group administrators for eligible direct costs incurred prior to grant contract execution beginning on February 1, 2021; and (b) transfer associated funds from the Water Assistance Fund to the Research and Planning Fund. 2. Approve by resolution a request from the City of La Villa (Hidalgo County) for \$250,000 in financial assistance consisting of \$140,000 in financing and \$110,000 in grant from the Flood Infrastructure Fund for a flood planning study. (Claudia Corsetti)
3. Approve by resolution a request from the City of Port Arthur (Jefferson County) for \$455,000 in grant from the Flood Infrastructure Fund for a master drainage plan project. (Jessica Taylor)
4. Consider approving by resolution a request from Val Verde County to amend the Texas Water Development Board Resolution No. 20-101 to extend the expiration period of the existing Flood Infrastructure Fund commitment. (Kathy Hopkins)
5. Water Conditions Report (Dr. Mark Wentzel)
6. The Board will receive comments from the public on any matters within the jurisdiction of the TWDB, with the exception of matters which are subject to the ex parte prohibition found in Texas Government Code Section 2001.061.
7. The Board may adjourn into Executive Session and conduct a closed meeting to consider any item on this agenda if a matter is raised that is appropriate for the Board to conduct a private consultation with its attorney on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code. The Board may conduct a closed meeting to receive legal advice and discuss pending or contemplated litigation, settlement offers, or the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of specific Board employees, including the Executive Administrator and General Counsel, as permitted by Sections 551.071 and 551.074, the Texas Open Meetings Act, codified as Chapter 551 of the Texas Government Code. The Board may also meet in open meeting to take action on legal or personnel matters considered in the closed meeting as required by Section 551.102 of the Open Meetings Act, Chapter 551 of the Government Code. The Board may conduct a closed meeting to consider and discuss financial matters related to the investment or potential investment of the Board's funds, as permitted

by Section 6.0601(a) of the Texas Water Code. The Board may also meet in open meeting to take action on a financial matter discussed in the closed meeting as required by Section 6.0601(b) of the Texas Water Code.

The next currently scheduled meeting of the Texas Water Development Board will be July 7, 2021. Other meetings may be scheduled and will be posted in compliance with the Texas Open Meetings Act.
