SUBJECT: Proposed Rule Review Plan for Agency Rules

ACTION REQUESTED

Consider adopting a rule review plan for the Texas Water Development Board related to its rules contained in 31 Texas Administrative Code, Part 10.

BACKGROUND

In July 2022, the Sunset Advisory Commission (Commission) completed its required Staff Report with Commission Decisions (Sunset Report) reviewing and making recommendations for the Texas Water Development Board (TWDB). This proposed action addresses items in Issue 3.

KEY ISSUES

Item 3 in the Sunset Report on the Texas Water Development Board directed the Agency to comply with Texas Government Code § 2001.039 to review its rules every four years, including determining whether the initial reasons for adopting the rules continue to exist. The Sunset Report instructed that the plan should include a schedule and the TWDB should consider filing its rule review plan with the *Texas Register*. The Sunset Report also requires the TWDB to submit to it a proposed plan of review for all of the Agency's rules by December 31, 2022.

The Executive Administrator instructed the Office of General Counsel to respond to the Sunset Commission's directives. Attached is a proposed schedule of review for the Agency's rules in 31 Texas Administrative Code, Part 10. Additionally, the *Texas Register* no longer requires state agencies to publish rule review plans; instead, the Office of General Counsel

will publish notices of intent to review certain Agency rules. Then after its review, it will publish and adopt the results in the *Texas Register*.¹

The Office of General Counsel has reviewed the last adoption date of each of the existing Agency rules contained in 31 Texas Administrative Code, Part 10. It proposes to review the following chapters of rules for the first quarter of calendar year 2023:

Title 31, Part 10, Chapter 353, Introductory Provisions Title 31, Part 10, Chapter 354, Memoranda of Understanding Title 31, Part 10, Chapter 380, Alternative Dispute Resolution

Following the review of the three aforementioned chapters, the Office of General Counsel will continue to rule the Agency's rules in accordance with the proposed rule review schedule recommended by the Executive Administrator.

RECOMMENDATION

The Executive Administrator recommends the adoption of a proposed rule review schedule for Agency rules in Title 31, Part 10.
