SUBJECT: Quarterly Contracting and Purchasing Report

ACTION REQUESTED

Briefing and discussion on material changes to contracts for goods and services executed during the fourth quarter of Fiscal Year 2024, and the contract and performance report for the fourth quarter of Fiscal Year 2024.

BACKGROUND

Pursuant to Section 2155.088 of the Texas Government Code, enclosed for your consideration are the material changes made to contracts for goods and services awarded under Chapter 2155 of the Texas Government Code for the period of June 1, 2024, to August 31, 2024. See Attachments 1 and 2.
