

Application Intake Summary and Prioritization Review

Executive Summary

The Water Supply Infrastructure Grant (WSIG) Program represents a one-time \$1 billion funding opportunity designed to support critical water infrastructure needs across Texas.

During the application intake period, the Texas Water Development Board (TWDB) received a total of 686 applications. Of these, 676 applications were received by the established deadline and are currently under review as part of the prioritization process. These applications represent a total requested amount of \$6,901,946,826.54. An additional 10 applications were received after the submission deadline and are ineligible for consideration under this funding opportunity.

The substantial number of applications and amount of funding requested demonstrates the significant statewide demand for water infrastructure investments. The applications currently under review represent a wide range of projects seeking to address critical water supply, system reliability, and infrastructure improvement needs. Staff are actively reviewing eligible applications to assess program requirements, project eligibility, and funding considerations.

This report summarizes all applications received and supports the ongoing evaluation and prioritization process for this one-time funding opportunity.

Note: Applicants included in this report do not constitute a determination of eligibility, technical feasibility, funding recommendation, or grant award. Prioritization results remain subject to further review, validation, technical evaluation, and approval by the TWDB. Requested funding amounts presented in this report reflect the amounts submitted by applicants and should not be interpreted as funding amounts under consideration or recommended for award.

As part of the review process, TWDB staff may issue Requests for Information (RFIs) to applicants to obtain clarification, supporting documentation, or additional information necessary to complete the evaluation of an application. Applicants are encouraged to closely monitor the email address provided in their application and be prepared to respond promptly to any RFI. Applicants will have three (3) business days from the date an RFI is issued to provide a complete response. Failure to respond within the allotted timeframe will result in the application being deemed ineligible and the application will not be considered further for funding.
