Work Completed

This report summarizes activities on project tasks for June of 2021 and is the seventh contract progress report. Tasks 2, 4, 7 and Task 8 were active in the reporting period and had time billed to them. Progress on those tasks will be summarized below.

Task 2 Stakeholder Communication

On June 18th INTERA submitted a revised draft of report Section 2, Review of Applicable Statutes and Codes to the TWDB. INTERA had received comments from both the TWDB and the TDLR on Section 2 on May 28th. Because TDLR is the principal stakeholder on this project, edits and associated billing was charged to Task 2. The revised section was submitted to the TWDB with the entire draft report on June 30th.

Task 4 Statewide Survey of Commingling Issues

On May 17th, a draft of the Statewide Survey Section was submitted to TWDB for their first review. Comments on this section were returned on May 24th. The revised section was submitted with the entire draft report on June 30th.

Task 7 Recommendations and Need for Further Study

A draft of the study conclusions and recommendations was submitted to TWDB on June 27th for a pre-review to the draft report. A complete draft of the study findings, conclusions and recommendations was submitted with the entire draft report on June 30th.

Task 8 Reporting

Activities on Task 8 were focused on completion and submittal of the draft report and completion and submittal of the draft data model. Both deliverables were delivered on schedule on June 30th.
