Work Completed

This report summarizes activities on project tasks for July and August of 2021 and is the eighth contract progress report. The draft report and associated electronic files were submitted to the TWDB on schedule on June 30th. INTERA received comments in two methods: redline edits to the word document and official submittal of general comments. INTERA received draft redline comments on August 3rd and August 6th. We also received the official submittal of general comments on August 6th. All activities in July and August were focused on responding to TWDB comments.

At the end of June, we had \$4,956.25 of the project budget remaining. The remaining amount was distributed across 7 of the 8 projects tasks. In the months of July and August INTERA accrued costs more than the remaining budget. For our final invoice, we have accrued costs in the 7 tasks with remaining budget.

The final report and the electronic data deliverable will be delivered to the TWDB on August 31st.
