As a follow-up to comments submitted on September 22nd, I would like to add the following suggestions which primarily involve extending summary comments throughout other sections in the draft State Plan. Thank you for the opportunity to provide comments.

Page 149 (Reservoir Yield table for Nueces River Basin):

Add to * footnote: Combined yield of Choke Canyon Reservoir, Lake Corpus Christi, and contracted supplies from Lake Texana.

Is this accounted for in the Lavaca River Basin reservoir yield summary, page 147?

Page 261 (Table 10.1)

Municipal water conservation was recommended by the Coastal Bend Regional Planning Group for high water use entities, regardless of needs.

Revise New supplies from municipal conservation (acre-feet per year): 2,415 acft (Table 4C.1-4 and discussions in water supply plans.)
Estimated capital costs (millions of dollars): 0.80
Average annual unit costs per acre-foot of water: \$342

Page 265 (Table 10.3)

It appears that supplies from the CCR/LCC pipeline were inadvertently included in "New Major Reservoirs" supplies. Revise to 42,005 acft to include supplies from the off-channel reservoir (with USCOE participation) and Stage II Lake Texana.

Revise percentage of all new supplies from new major reservoirs from 46% to 29% (revise text on pg 267, as well).

Add phrase to table header to indicate that the table excludes surface water supplies from desalination.

Page 274 (Table 10.7)

38 For desalination project, clarify conveyance from "Barney Davis Power Station" to "Corpus Christi and San Patricio Municipal Water District".

39 For Garwood project, clarify conveyance from "Lower Colorado River" to "Mary Rhodes Pipeline connection near Lake Texana"
